FACTS What does Money 4 You/Mr Money do with your personal information?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect, and share depend on the product or services you have with us. This information can include:</p> <ul style="list-style-type: none"> • Social Security and driver's license numbers • Street and email addresses • Employment information and telephone numbers • We may collect certain information automatically when you use our services, such as your IP address, browser type, operating system, and other metadata. This information is used for fraud prevention, analytics, and enhancement of our services. <p>When you are no longer our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal info; the reasons PDQ Check Exchange llc chooses to share; and whether you can limit this sharing.

Non- affiliates	Financial or non-financial companies that are not related by common ownership or control. <ul style="list-style-type: none"> • PDQ Check Exchange does not share your information with non-affiliates for marketing purposes.
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> • PDQ Check Exchange does not have joint marketing partners.
